# PRICES & TERMS

Consistent with our practice of offering customers the lowest possible pricing, all prices quoted in our product line are net FOB our warehouse. Our payment terms are Net 30 or credit card (Visa or Mastercard). To customers establishing credit, we will ship orders on open terms, 30 days net. Our finance charge is 1.5% for past due balances and is expected to be paid along with the full balance.

#### RETURNS

No returns will be accepted unless accompanied by our authorization. Authorized returns and exchanges must be made within 10 days after the date good were received. Authorized defective goods or goods shipped in error are subject to a 15% restocking fee. <u>NO RETURNS AFTER 30 DAYS</u>.
